Directors of the Company namely Mr. Yeung Kwong Fat, Mr. Lee Kam Hung, Mr. How Sze Ming, Mr. Jung Chi Pan, Peter and Mr. Mak Tung Sang attended the 2023 AGM in person. Mr. Luk Yau Chi, Desmond did not attend the 2023 AGM due to other business arrangement.

Tricor Investor Services Limited, the Company's Hong Kong branch share registrar was appointed as the scrutineer at the 2023 AGM for the purpose of vote-taking.
